(57) **ABSTRACT**

A hot melt adhesive composition that includes thermoplastic
polymer, a source of zinc, at least one of aluminum trihy-
drate and magnesium hydroxide, and no greater than 70% by
weight of a source of halogen. Articles that include a porous
substrate and the hot melt adhesive composition.
